



MySpace Discovery

Lawyers are mining social networks for nuggets of evidence

FRIENDS, ENEMIES, POTENTIAL employers—and now even attorneys—may be checking out your MySpace page. MySpace and other social networking sites on the Internet can be caches of evidence.

"A few years ago, lawyers would call and say they had no idea what [MySpace] was," says Jeff Fischbach, a Chatsworth, Calif., forensic examiner, "but now everybody keeps talking about it."

Criminal defense lawyers use social networking sites the most, usually to investigate witnesses, according to Fischbach.

"It's a tool that is out there," says Eugene, Ore., lawyer Laura Fine, who found evidence on the Net while she represented a teenager accused of forcible rape.

The witness told police that

she would never willingly have had sex, according to Fine, but her page on MySpace said something different.

"She talked about parties, drinking and 'getting some,'" Fine says.

The page also displayed provocative photos of the young woman, according to Fine, and a lascivious screen name.

The page was meant to be private, but lawyer Fine viewed it over the shoulder of another witness, who gained access through a MySpace group he and the girl belonged to.

The girl's parents would not allow the lawyer to interview her, but Fine says she found out what she needed to know from the site. She also got a good sense of how the young woman would present to a grand jury.

Based on what she read, Fine called the girl as a witness, and ultimately the grand jury dismissed the charge.

"What you put on MySpace, essentially, becomes public consumption. There's no right of privacy," says John Wesley Hall Jr., a Little Rock, Ark., criminal defense lawyer who writes extensively on evidence issues.

Besides looking for information on witnesses, Hall investigates clients through various personal Web pages.

"I'd rather know where the land mines are so I don't walk into one," he says.

Prosecutors, Hall adds, generally don't use online networking sites as much.

Often, that's because they end up with better evidence obtained through search warrants, says Clinton Parish, a Yolo County, Calif., deputy district attorney.

A POST ISN'T PROOF

PARISH IS PROSECUTING A CASE IN which police say they found information about marijuana sales on a MySpace page. Police used the page, which included images of the suspect, his girlfriend and his car, to get a search warrant, Parish says. Rajneel Kumar was arrested and charged with felony possession for sale of methamphetamine and marijuana.


But proving Kumar wrote the text detailing his business or posted pictures of his alleged marijuana plants may be difficult. Evidence seized during the search warrant could prove more effective in the prosecution, Parish says.

Fischbach predicts that as lawyers become more familiar with networking sites, prosecutors will use them more frequently.

"It would be really wise if attorney [did an Internet search] for all the individuals involved in a case, just so they know what they're up against," Fischbach says.

What's On Your Witness's MySpace Page?

As more and more people post personal information on social networking sites such as Facebook.com, Myspace.com, and even Match.com, attorneys are increasingly seeking discovery of such evidence, which is becoming commonplace in civil and criminal trials. Users' pages often contain a wealth of personal facts, photographs, and videos, and links to other sites. Not surprisingly, colleges and employers now check applicants' web pages on a regular basis.

Civil Cases

The defendant in a sexual harassment case sought to compel production of emails from two MySpace.com accounts.





A few hours after NBA star Kobe Bryant had sex with a Vail-area hotel worker last summer, the woman exchanged cell phone text messages with a former boyfriend and someone else.

Verizon recovers dead wife's deleted voice message for husband

- IRVINGTON, N.Y. -- An 80-year-old man can hear his late wife's voice again, any time he wants.

Verizon has recovered a lost message recorded by Charles Whiting's wife, Catherine, before her death in 2005.

When Verizon upgraded the man's telephone service, his wife's voice disappeared from his voicemail system. The message said "This is Catherine Whiting," and her husband said he listened to it every day for comfort.

Verizon spokesman John Bonomo said Tuesday that a contractor found the recording in an archive and restored it to the new voicemail system.

T-Mobile

- Does not save text message content for any period of time
- Call records (which includes text message records) are stored for prepaid phones for 2 years and for monthly phones since 2000
- Stored 30 days for prepaid phones and 90 days for monthly billed phones

Sprint (Nextel)

- Text message content: Sprint stores for 14 days and Nextel for 7 days
- Origination and destination of calls and texts: 60 days for Sprint and 18 months for Nextel
- For cell tower information, need a court order or search warrant and the information is stored for 60 days for Sprint and 18 months for Nextel

AT&T

- Does not store text messages
- Policy not to delete call and text records, but since it recently bought out other companies, they only have the records of the other companies as far back as that company stored them
- They store cell tower information for 90 days

- Four months later, Bryant's attorneys subpoenaed AT&T Wireless Communications Inc., seeking the messages. The company fought the subpoena, but retained the messages. The company fought the subpoena, but last month state District Judge Terry Ruckriegle ordered the company to turn the messages over to him.

He will review them in private to determine whether they are relevant to the case, in which Bryant has pleaded not guilty.

AT&T Wireless spokesman Mark Siegel said the company cooperates with law enforcement officials for investigations but refused to discuss its policies on storing text messages.

The company's Web site said messages not immediately delivered are held for 72 hours for more delivery attempts - then deleted. How messages in the Bryant case would be available four months later isn't known; most likely they were retrieved from an archival storage system.

- Travis Larson, spokesman for the Cellular Telecommunications and Internet Association, said information about text messages - including the sender, recipient and location of sender - is always stored for billing purposes. The software used to store that information also can store content.

Police and Prosecutors Get It!

Web networking photos come back to bite defendants

Two weeks after Joshua Lipton was charged in a drunken driving crash that seriously injured a woman, the 20-year-old college junior attended a Halloween party dressed as a prisoner. Pictures from the party showed him in a black-and-white striped shirt and an orange jumpsuit labeled "Jail Bird."

In the age of the Internet, it might not be hard to guess what happened to those pictures: Someone posted them on the social networking site Facebook. And that offered remarkable evidence for Jay Sullivan, the prosecutor handling Lipton's drunken-driving case.

Sullivan used the pictures to paint Lipton as an unrepentant partier who lived it up while his victim recovered in the hospital. A judge agreed, calling the pictures depraved when sentencing Lipton to two years in prison.

Online hangouts like Facebook and MySpace have offered crime-solving help to detectives and become a resource for employers vetting job applicants. Now the sites are proving fruitful for prosecutors, who have used damaging Internet photos of defendants to cast doubt on their character during sentencing hearings and argue for harsher punishment.
